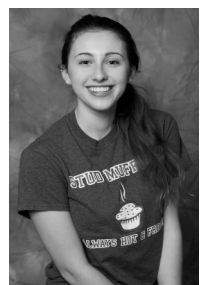

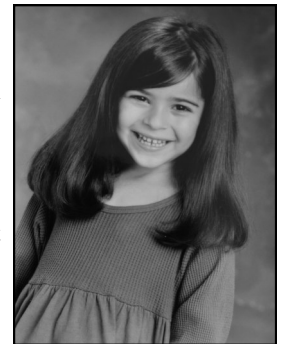

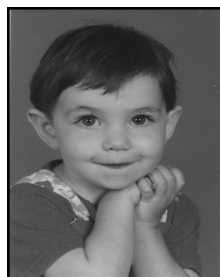


## Senior Biographies

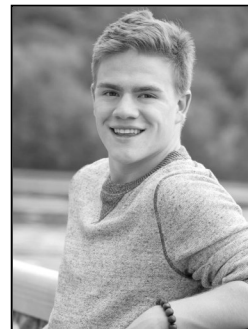

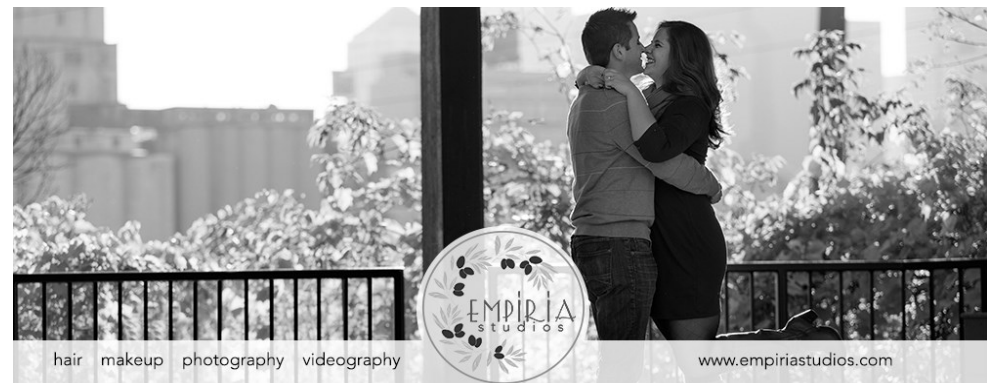
